- The sealed envelop should be superscribed "sealed tender regardingCD/DVD preparation from bilingual conversation guide." The tender should reach by hand or by post to Dr.Anuradha Sengar, Assistant Director, Department of Correspondence Courses, Central Hindi Directorate, West Block-7, R.K.Puram, New Delhi-110066 lates by 18.02.2019 till 05.00 evening and tender will be opened on 19.02.2019 at 3.00PM.
- Empanelment on the basis of tender will be valid or three financial years i.e. 2019-20, 2020-2021 and 2021-22 but this does not imply that the Directorate is bound to allot the work to the same firm for three following years. Work will be allotted to the firm/firms on the basis of their last performance at Directorate.
- 4) Directorate is free to allot the work to more that one firm to complete the work as per plan and on time.
